### INFORMATION for EXHIBITORS

#### DATE, TIME and LOCATION:

The event will take place on Thursday, August 8, 2019, from 8:30 a.m. to noon at the HCC SouthShore Campus, 551 24th Street N.E., Ruskin, FL 33570

#### COST:

Admission is free for job fair attendees. A 6-foot table and 2 chairs will be provided free to exhibitors.

#### EXHIBITIONS:

The event exhibition areas at HCC SouthShore Campus will be open for installation and preparation after 7:30 a.m. on August 8, 2019.

To keep the event free to companies and job seekers, we cannot supply any materials other than a 6-foot long table and two chairs for each exhibition station. We recommend bringing display stands, nylon string, tablecloths, scissors, book ends and anything which can facilitate setting up your exhibition station. We recommend that all exhibitors have bilingual information available at the exhibit, if possible.

The management at HCC SouthShore Campus prohibits attaching any signs to the walls with tape, tacks, sticky substances, or anything else. Please let us know one week in advance if you require electricity (you will need to supply your own extension cords).

Exhibits must be open to the public until noon. Breakdown is from noon until 1 p.m.
